Chief Larkin stated that the training tower product is scheduled to arrive on May 17 and construction will begin soon thereafter.

He reported that the new fire truck is on order and is expected to arrive in September.

As to Station 41 progress, Chief Larkin reported that we are on time to have all the questions answered which came back after the Draft EIR comment period.

Chief Larkin indicated the Cal Fire labor contract is moving forward through Legislation for approval and then goes to the labor group for ratification. Figures are being put together now and will be given to the Board.

Director Stockman reported that he has completed all three required Board member courses.
