Sealed bids are due no later than 11:00 a.m. on Friday, October 18. All bids must be sent via mail or hand delivered to Coastside Fire Protection District, Administrative Office, 1191 Main Street, Half Moon Bay, CA 94019.

Any bids received after the time and date specified will be rejected. Any bids delivered to a location other than the Purchasing address will be rejected. Emailed and faxed bids will not be accepted.

SUBMISSION REQUIREMENTS

Bidders must complete the enclosed Price Sheet for submission of bid. All submissions must be signed, dated and contact information provided. Please write legibly. To submit a bid, place your Price Sheet in a sealed envelope, write on the envelope “**Coastside Fire District Sealed Bid 2008 Chevy Pickup**” and then write your name in the upper left-hand corner. All submissions must be received by the Fire District no later than 11:00 a.m. on Friday, October 18, 2024.

NOTIFICATION OF AWARD

Award will be made to the highest bidder. If you decide that you do not want a vehicle after you are contacted that you are the highest bidder, you will be banned from bidding on District auctions for a period of not less than five years.

REMOVAL DATE

Vehicles must be removed from Coastside Fire Protection District Property within ten (10) business days notification of award and full payment.

PAYMENT SCHEDULE

Successful bidder shall present a certified check/cashier’s check issued to Coastside Fire Protection District for the total amount of the awarded vehicle before receiving the title, keys and vehicle. Payments shall be delivered to Coastside Fire Protection District, 1191 Main Street, Half Moon Bay, CA 94019. Only after receipt of payment will the District issue the keys and title to the awarded bidder.

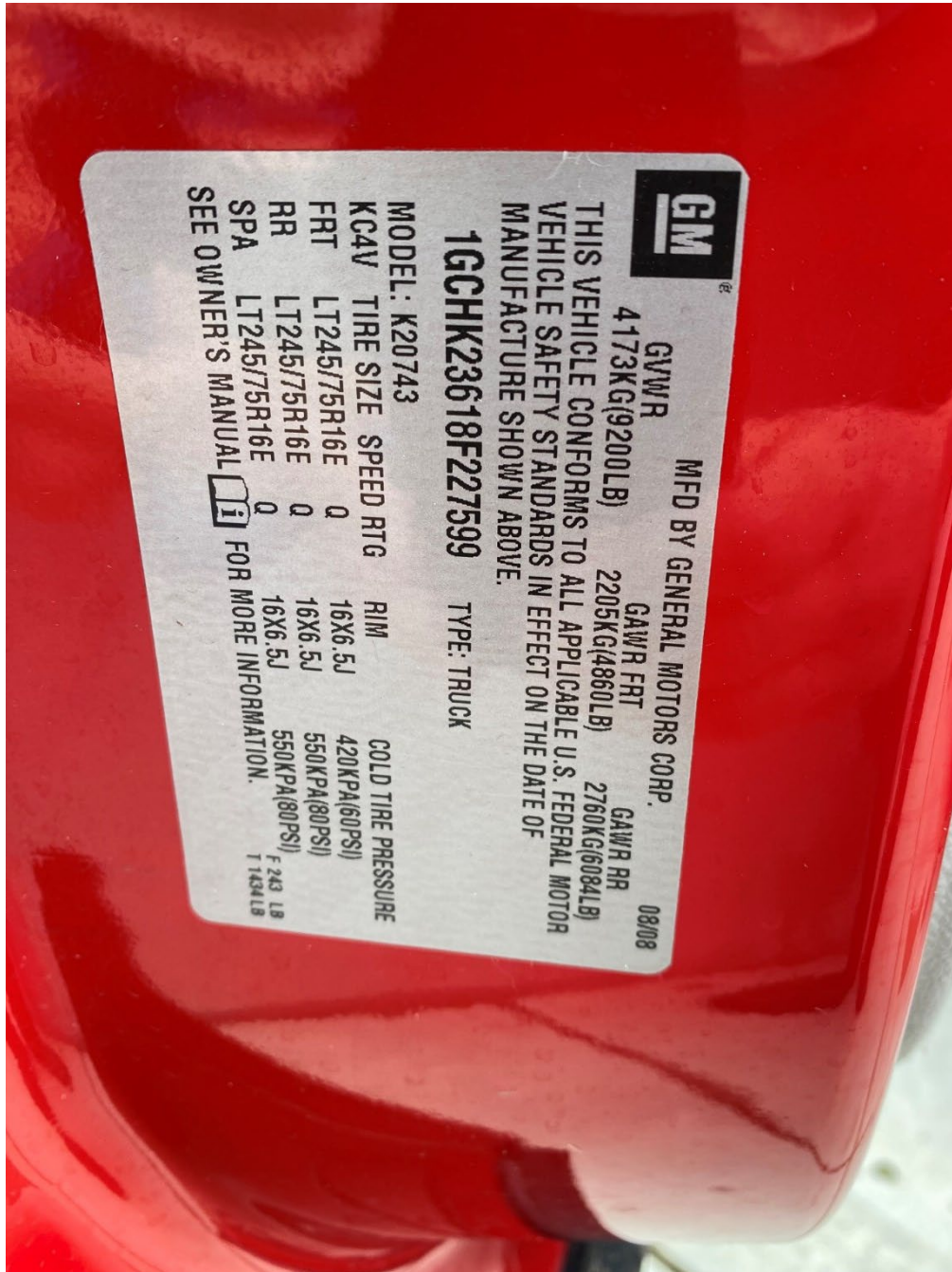

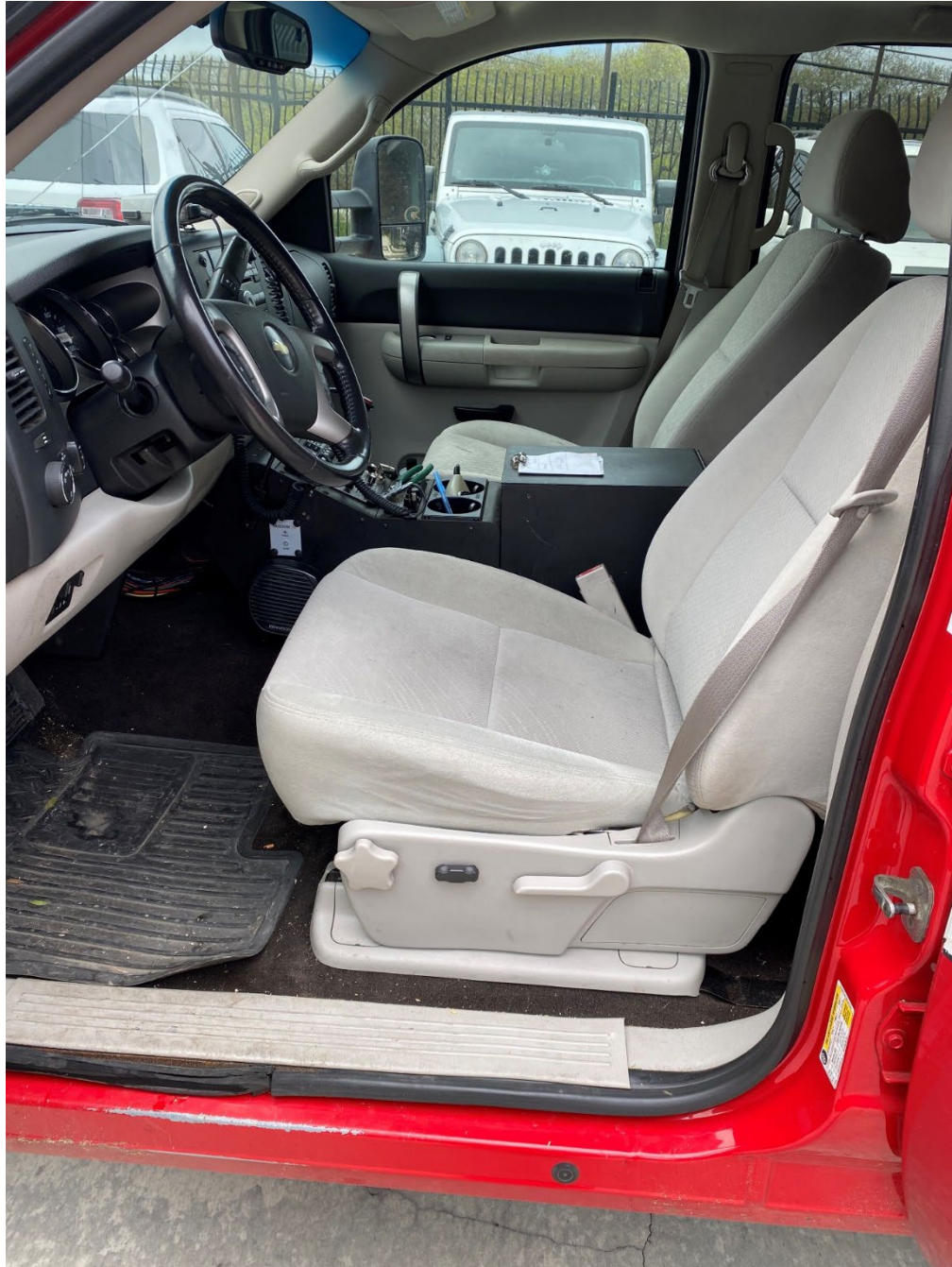
